Testing is done on a pass/fail basis on units and accessories as submitted by the manufacturer. Approved by NIOSH on the first submittal was Survivair's Panther SCBA 4500 psig unit, including all cylinders with locking collar only, the Panther-style bell alarm and warbling whistle alarm, all facepiece and nose-cup sizes (facepieces in black only), the Survivair Kevlar® Headnet<sup>™</sup>, and a number of accessories including COMPASS® with optional ThermAlert<sup>™</sup> DoublePASS<sup>™</sup>, and Survivair's buddy breather with optional check valve.

A second submittal is currently undergoing testing to extend the range of Panther SCBA products and accessories able to carry the "CBRN Agent Approved" label.
