1. PROTECTION

2. CAUTIONS AND LIMITATIONS

- A- Not for use in atmospheres containing less than 19.5 percent oxygen.
- B- Not for use in atmospheres immediately dangerous to life or health.
- C- Do not exceed maximum use concentrations established by regulatory standards.
- F- Do not use powered air-purifying respirators if airflow is less than four cfm (115 lpm) for tight fitting facepieces or six cfm (170 lpm) for hoods and / or helmets.
- H- Follow established cartridge and canister change schedules or observe ESLU to ensure that cartridges and canisters are replaced before breakthrough occurs.
- I- Contains electrical parts which have not been evaluated as an ignition source in flammable or explosive atmospheres by MSHA / NIOSH
- J- Failure to properly use and maintain this product could result in injury or death.
- L- Follow the manufacturer's User's Instructions for changing cartridges/and or filters.
- M- All approved respirators shall be selected, fitted, use, and maintained in accordance with MSHA, OSHA, and other applicable regulations.
